Call to Order

Terri opened the meeting at 12.26pm

Minutes of Vestry meeting held on August 19, 2018

Dennis moved to approve the minutes of August 19, 2018 Vestry meeting; Diana seconded. There
was no discussion and the motion was approved, with six Vestry members in favor

Diocesan Apportionment for 2019

- On September 14, Carolyn made on online motion that Christ Church fulfill its full diocesan
 apportionment pledge for 2019 of \$29,884 and Diana seconded the motion. There was no discussion.
 Voting ended on September 15 and the motion was approved with eight Vestry members in favor and one did not respond.
- Terri notified Mark Miliotto (our Diocesan Treasurer) of this commitment by email on September 15

Agenda

 The updated agenda as emailed by Carolyn on September 14 was accepted, with the addition of items on Property (Michael), on-line giving (Carolyn, Kevin), Rector sabbatical (Terri)

Opening

Terri opened with prayer and led a discussion and exercise on Mark 9:30-37 (today's Gospel)

Mission Field

- Three Renaissance Goals 2018/19; Next Steps - Carolyn
 - Vestry member feedback from table discussions at Adult Forum on September 9th
 - Social justice: implement with small groups.
 - Need to be 'educated' in citizenship in order to play a role in society and work towards social justice
 - English as a second language
 - Need to make a start on projects
 - Improve communications
 - Get to know each other e.g. supper groups
 - Check-in conversation during worship to raise issues/concerns ahead of prayers of the people
 - Consider a talent corner fund raising during coffee hour based on people's skills
 - Consider adding a Women's group alongside the Men's group. It would be raised up when someone feels call to action (as Doug Philips did with the Men's group)
- Next Steps - Carolyn

- Each group needs to meet, engage RSTF team members and develop an implementation plan
- o Reminder of implementation teams and Vestry participation (leader in **bold** text):
 - Goal #1: Offer opportunities for all to experience deeper spiritual engagement/support on their spiritual journey. Lynn Becker, Holly Schanz, **Diana Brehob**, Barb Hall
 - Goal #2: Deepen relationships with community groups, families and individuals already using the building (invite to engage in Christian fellowship). Selia Danes, Carolyn Blackmore
 - Goal #3: Develop social justice initiatives. Michael Mroczyk, James Thornton, Dennis Kirchoff
 - Renaissance Activities must meet at least four of following criteria:
 - Requires broad parishioner involvement
 - Effectively responds to an identifiable parish or community need
 - Does not deepen CEC financial deficit
 - Attracts/is relevant to multi-generational
 - Fosters collaboration
 - In addition, Terri is forming a 'Baptized for Life' group that may align with one of the three Renaissance goal team, or it may follow a separate path as a fourth implementation team

• Three Renaissance Goals 2018/19; Process for accessing Greenwood funding - - Carolyn

- The Greenwood beguest is available to support Renaissance implementation team plans
- Vestry will listen for plans emerging from implementation teams and develop an approach for appropriate allocation of funds from this bequest

• Baptized for Life (BfL) - - Terri

- Terri sent an email (September 22) to the Parish summarizing the meetings with Maureen Hagen along with the topics discussed
- Terri will meet with Stephanie Mulkern and Darrell Donakowski, who have agreed to serve on the BfL implementation team, to discuss adding 3 or 4 additional members and a Vestry representative

• Finance - - Carolyn Blackmore / Kevin Green

- o Carolyn provided an update on the Church's projected deficit position for 2019
 - The Church (150th Annual meeting on January 29th 2017) agreed to allow Vestry to use Endowment funds to finance the annual deficit
 - We can be proud of being a Church that keeps the doors open
 - The Stewardship 'Consecration Sunday' program in 2017 resulted in an increase in the number of pledging households
 - We continue to add new members, but overall numbers are steady due to bereavements and people moving away
 - 2019 expenses will be higher as we hire an organist/choirmaster (replacing Sean Jackman),
 cover a portion of the Curate's costs, experience reduced giving among the largest giving
 households and will have a lower, or zero, carry over cash
 - The deficit for 2019 is likely to be in the range \$45-\$60,000
- Kevin provided the Treasurer's report and covered the month of August and our year-to-date (YTD) status
 - August was a good income month (pledges exceeded budget) but expenses were even greater, resulting in a deficit for the month of approximately \$5,300 (versus a budgeted deficit of \$2,400).

Part time Custodian and Contracted Grounds Services

- In a meeting on Tuesday (September 11, 2018) Michael met with The Rector and John Jones (Sexton) and agreed that CECD will no longer use a part time custodian (Sexton's assistant), but it is likely that there will be a need to assist the Sexton with selected tasks before the end of this budget year.
- Carolyn made a motion that Vestry authorize spend in account 686 (Contract Grounds Services) up to any amount that would otherwise be unused in account 622 (Part-Time Custodian). Dennis seconded the motion. There was no discussion and the <u>motion passed</u> with all six Vestry members present in favor.

OnLine Giving

- A contract will be entered with SwipeAway for online giving with the goal of having this in place in the second half November
- Vestry acknowledges that Kevin Green, in his official capacity as Treasurer, will allow use of his Social Security number to allow the Church to enter into a contract with SwipeAway for online giving

Gift in memory of Matt & Jean Piernick

- Carolyn made a motion to accept the donation of \$200 in memory of Jean and Matt Piernick
 to be applied to the Property Commission dedicated account. Dennis seconded the motion.
 There was no discussion and the motion passed with all six Vestry members present in
 favor.
- Kevin will ask Todd Kappauf and Michael Mroczyk to send a thank you letter on behalf of the Property Commission

• Environmental Initiatives; Churches going solar - - Michael, Carolyn, Dennis

 Carolyn, Michael and Dennis attended a workshop on this topic and will continue to evaluate opportunities and plan next steps. There is a sense of urgency because any solar installation completed before the end of 2019, would be grandfathered into legislation that allows electricity generated to be returned to the grid for credit against our energy bills

Christian Formation - - Carolyn

- Michigan Interfaith Power & Light is an interfaith group exploring how to use alternative energy sources in places of worship
- There are examples of places of worship self-financing, securing outside funding and using electricity provider funding (investor)
- Bob Chapman, Executive Director Michigan Interfaith Power & Light, will lead Adult Forum on September 30 to brief parishioners on this energy and cost saving opportunity
- Planned and likely changes in the regulatory environment mean that this is a good time for the church to consider this investment in our future

• Stewardship - - Carolyn

• The leadership dinner is at 5pm on October 28th and all Vestry members and a partner are invited to attend and are asked to put the date and time on their personal calendar

• Worship Music Ministry - - Diana

- Ann Bakalyar will cover the period through end 2018 and has requested Sundays off. These dates will be covered by Cary Dumas, Manuela Blankinship and Katharine Walters
- The proposed position for permanent Organist and Choir Master will be structured as a ninemonth contract (September through May) with an option of summer services at the supply musician rate. The goal is to start the new contract in late January 2019

Any Other Business

Faithwalking - - Terri

- A second, in-person Faithwalking 101 class is being offered at Christ Church (October 21st and 22nd).
- This will cost \$2,000 for trainer expenses plus \$500 for meals and other costs. The alternative would be to encourage parishioners to take the on-line course. Both in-person and on-line training require per-person registration payments, but on-line does not incur other expenses for the Church
- Holly made a motion that the Church commit up to \$2,500 for the second in-person Faithwalking 101 class in October. Diana seconded the motion. There was no discussion and the motion passed with five Vestry members in favor and one abstention

Communications Commission – Dennis

- Dennis will document his thinking for Vestry consideration and discussion at the November meeting
- Dennis commented that the work of this team will go beyond formation of a Commission and may recommend changes in the way CECD communications are structured and managed

Rector Sabbatical

- Terri has accrued a total of 14 weeks sabbatical leave and will take it over the next 2-3 years
- Funding is available in the Bagley Sabbatical dedicated account, as established by Vestry
- Terri's first week of sabbatical leave will be November 6-13 in Portland Oregan, for a seminar on inter-cultural inventory and awareness

Next Vestry meeting - - Carolyn

- Carolyn reminded the meeting that the next Vestry meeting will be held on October 21, 2018 gathering at 12.15pm to start promptly at 12.30pm.
 - Vestry noted that Carolyn and Dennis are not available for the 10/21 meeting
