#### **Mission Field**

- Renaissance Strategy Task Force (RSTF) update -- Sue Bennett
  - The group is looking forward to the joint meeting between RSTF and Vestry on Tuesday evening May 29 at 7pm in the Lounge
  - The group has been meeting bi-monthly for over a year
  - A successful Renaissance at Christ Church will rely on whole church engagement
- Building Usage Group update Margaret Green
  - For the past year a committee of Margaret, Ron Jurgens, Pat Snyder, Donna Behm, Selia Danes, Nancy Lehnert and Dennis Kirchoff has been reviewing policies and procedures for building users at CECD
  - A welcome packet of information for building users has been developed, including: building use agreement, facility use guidelines and relevant policies
  - Discussion of the document will be scheduled at the June Vestry meeting
- Faithwalking workshop June 1 & 2 -- Terri
  - Registration closes on Friday. The seminar will be cancelled if less than twelve people register
- Baptized for Life program Terri
  - Learn more at http://baptizedforlife.org/ and click on 'Catechumenate' in the menu bar

- This program, from Virginia Theological Seminary (VTS), has been developed to promote spiritual growth in congregations
  - The program has a grant from the Lily Endowment Inc
- CECD has been asked to be one of three parishes in the Diocese of Michigan to participate
  - There is a natural tie with Halim Shukair's (Curate Associate) ministry at CECD. Halim graduated from VTS this month
- CECD will be given the opportunity to apply for a portion of the grant to implement the program at CECD. The application is to be submitted by December 2018
- A parish wide pre-program survey is a part of the process; most likely occurring before mid-June

# The Vestry went into closed session from 1.40pm until 2.30pm

# <u>Curate Associate – Dennis and Carolyn</u>

- Dennis made a motion that CEC Establish a Curate Support Fund to be administered as
  provided for in the Covenant of Call with Halim Shukair. The motion was seconded by Selia.
  There was no discussion and the motion passed with eight Vestry members in favor, none
  opposed and one abstention
- Carolyn made a motion that Vestry designate a Curate Associate housing allowance of \$20,000 for 2018. Dennis seconded the motion
  - There was discussion about the housing allowance and the Curate's responsibilities for IRS reporting
  - The motion passed with all nine Vestry members in favor

#### Other Business

- Finance Update Kevin Green
  - Offering Plate Income and Total Income were over budget for April by about \$5,000. Year to date Offering Plate Income is about \$1,250 below budget
  - Year to date overall income is only approx \$900 below year to date budget
  - Expenses were generally at budget levels for April and overall \$6,500 below year to date annual budget
  - The year to date deficit is about \$5,500 better than forecast at stands at negative \$18,781
  - Servant Keeper software use is going well so far and Erin(office), Colleen (book keeping)
     and Kevin continue to learn how to use the various features and features
- Music Advisory Team update Diana Brehob
  - Diana, Selia, Terri, Chris Burkhalter and Shannon McKenney-Shubert. The first meeting of the group is Thursday next week
  - Cary Dumas has a recommendation for a person who can evaluate the refurbished organ and provide a report on the remaining adjustments required. Cary commented that the organ was much improved today, compared with the last time he served as substitute organist
- Vestry member phone calls to parishioners Carolyn Blackmore
  - As in summer 2017, Vestry members are being asked to contact all members. Returning Vestry members will contact the same list of parishioners contacted in summer 2017
  - Terri and Carolyn will provide each Vestry person with a new or confirmed list of people to contact; June 2018 talking points; and briefing for members who are new to Vestry since last year (Lynn, James, Holly and Barb)

The target is to have made these individual calls by June 10

#### Reflection

 Michael commented that Vestry should discuss Vestry start and end times with a goal to be consistent and predictable. Today's meeting started after forum, instead of at Noon and ran about 35 minutes longer than scheduled. One approach would be not to schedule an adult forum on the dates of Vestry meetings and plan to gather at 11.45am
