 Terri opened the meeting with prayer at 12.21pm, led a brief discussion based on a reading from Ephesians and read from the Episcopal Church of Scotland's Vestry Formation and Orientation recommendations on integrating worshipful church meetings

Agenda and Minutes of Prior Meeting - Nick Bell

- On January 31, 2018 Dennis made an eMail motion to approve the minutes of the January 28th organizational Vestry meeting. Michael seconded the motion. Voting remained open until February 4th and the motion passed with all nine Vestry members approving
- Review of Agenda sent out by Carolyn on email on February 10, 2018
 - Michael emailed a list of items that need to be discussed and completed by Vestry
 - Dennis, Michael and Carolyn will review and update the Undesignated Gift policy (carry over from September 2017 Vestry meeting)
 - Michael and Terri will complete the review of casual labor policy as it relates to unbonded labor and bring an update to a future Vestry meeting (carry over from December 2017 meeting)
 - Vestry responsibility to agree three to five annual goals, as called for under the Rector's covenant of agreement, that will be developed as part of the 2018 Mutual Ministry process
 - Terri has shared Vestry job descriptions and roles & responsibilities with Vestry members and time will be scheduled at a future Vestry meeting to review and consolidate feedback
 - Building Use Committee will bring an update to Vestry in May to document the guidelines for granting use of church buildings to individuals or groups outside the parish
 - Finance will be asked to develop a scenario plan for loss of the sponsorship of the two largest pledging households
 - Emrich Retreat Center 'Carved in Stone' appeal. Nick will discuss under 'Any Other Business'

Mission Field: Purpose of the Vestry - Terri Pilarski

- Terri recapped the role of Commissions in relation to the work of Vestry. Parish Life, Finance,
 Property, Stewardship and Worship are the current 'active' Commissions, although important and valuable parish work is done outside these by other groups, committees and ministry teams
- The Rector and Wardens discussed reducing the number of Co-missions and/or renaming Commissions to better reflect the Mission of Christ Episcopal Church. For example: 'Listening', 'Seeing', 'Being', 'Doing'. These alternative descriptors have the potential to be more accessible for the Millennial generation
 - Vestry discussed the need for, and a value of, a Formation/Education Commission
 - Dennis believes that we would benefit from a Communication Commission (both internal and external communication)

- Communication relates to Evangelism and how we welcome people new to our church and services, but is a distinct and separate mission
- Finance and Property might continue with their names unchanged as they provide core functions for the Church and Parish
- Any change will be communicated to the Parish for understanding and engagement
- This dialog will be continued in March

New Business

Minutes of 151st Annual Meeting - Nick Bell

- Terri asked that "Revd." (Terri Pilarski) be changed to 'Pastor' throughout the document
- Correct the provisional date of 184th Diocese of Michigan Annual Convention to October 26/27 and note that the location is to be determined
- With these changes to be made, Carolyn made a motion to approve the minutes for the 151st
 Annual Meeting held on January 28, 2018. Michael seconded the motion and the motion passed with all nine Vestry members approving

- Michael reminded the group of the Vestry Formation and Orientation document that included Vestry job descriptions and roles & responsibilities that Terri has provided to each member and requested that time be allocated to discussion of this material. This will be scheduled in March
